A small task force consisting of Hans Bynagle, Pat Partovi and John Hasko met on March 28, 2012 to review the INCOL Rules and the Agreement to see if they could find a way to continue INCOL and the Continuing Education committee. The issue is that the Joint

Board as outlined in the Rules and Agreement is unable to achieve a quorum to attend a meeting to vote, or even to vote via email in order to conduct the regular business of the Council.

Hans reported that the members continue to pay the required dues and continue to send people to the continuing education workshops offered each year. They do not, however, wish to participate fully in the conduct of business for the Council. Proposed amendments to the Rules for both the Council and the CE committee have been generally accepted and put into use by the CE committee but they have not been approved by the Joint Board.

The task force decided to make the following proposal to the membership and to divide up the list of members and make phone calls to those directors who do not respond to a vote by email.

#### **Changes to Operating Rules and Regulations:**

#### **Composition of Governing Board:**

Instead of all members having a seat on the Joint Board the Board will consist of Chief Librarians of the member institutions who volunteer to serve on the board. The board shall consist of no less than 7 and no more than 11 volunteers, ideally with a balance between academic and public libraries in order to represent the broadest range of types of libraries. If more than 11 volunteer and any dispute arises, then an email election will take place and whoever gets the majority of votes cast shall be elected.

#### **Meetings of the Joint Board:**

The Joint Board shall meet at least once a year in the spring at a time and place to be specified by its Chair. The Joint Board shall approve the budget for the following fiscal year and will elect new officers as necessary with their terms beginning on July 1, the start of the new fiscal year. The annual spring meeting will be a general membership meeting and all member directors are invited to attend. Other meetings of the Joint Board may be called as needed.

#### **Officers:**

The Chair shall be elected by the Joint Board for a 3 year term and the managing institution shall serve as Treasurer.

The task force endorsed the changes proposed in October 2009 to the CE committee guidelines. If these changes are approved in theory then the task force will work on the specific language and changes needed to the Agreement and the Operating Rules and Regulations.
