



6a. What were the strong points of the program: Preparing Your Collection Development Policies to Support Intellectual Freedom?

- Focus on does the item meet our purpose and policies, not content.
- Practical takeaways regardless of where you are at in this process.
- Focus on what we do, rather than what we don't do.
- Avoid content review. Instead review whether or not the library is following acquisition policies
- Make policies to stick to.
- Just the whole concept of not arguing about the content but talking about how the item met your collection development policies instead. Good ideas about promoting freedom to read and not about banning.

6b. What were the strong points of the program: Telling the Intellectual Freedom Story: Strategies to Prevent and Navigate Intellectual Freedom Challenges?

- Creating good rapport with community partners
- Prepare in advance so that you are ready when an item is challenged
- Information is a Right
- Many titles are part of the historical record of how we got to where we are. Removing them doesn't mean it didn't happen in history, it just leaves holes in the historical record.
- Evaluate items based on if they met policy requirements, not on content.
- Creating partnerships for IF support and ideas for staff training.
- I liked how easy the dialogue was to use and how really thinking about my community and how the library can be impacted by that community is so important.
